If legal or other requirements mean you must buy items you did not specifically ask for, we will explain the reason, in writing, on the statement we provide, describing the funeral goods and services you selected.

PROFESSIONAL SERVICES

Basic services of funeral director and staff

\$415

Our fee for the basic services of funeral director and staff includes, but is not limited to, conducting the arrangement conference, planning the funeral or creation, shelter of remains, obtaining necessary death certificate and permit, and administrative and clerical services. (This fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving remains. If our staff travels more than 10 miles to make the arrangements there will be an added charge of \$25.)

Embalming

\$600

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial. It is the policy of our firm to require embalming when there is public viewing of remains.

Refrigeration

This charge does not include any rites or ceremonies. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are minimum cardboard and minimum plywood.</i>	\$526 to \$535
