## **PROFESSIONAL SERVICES**

### **Basic services of funeral director and staff**

*Our fee for the basic services of funeral director and staff includes, but is not limited to, conducting the arrangement conference, planning the funeral or cremation, shelter of remains, obtaining necessary death certificate and permit, and administrative and clerical services. (This fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving remains.)*

### **Embalming**

**\$650**

*Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial. It is the policy of our firm to require embalming when there is public viewing of remains.*

This charge does not include any rites or ceremonies. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are minimum cardboard and minimum plywood. **For transfers that require two attendants for a residence \$ 1,101.71***
